

Rules of conduct and hygiene requirements for a safe and healthy stay at the Schneeberghof

General measures:

- Please keep your distance!
- Continue to refrain from shaking hands and hugs.
- Wash your hands several times a day with soap and water for at least 30 seconds and use hand disinfectant.
- Pay your bill contactlessly and have the consumptions booked to your room during your stay.
- Sneeze or cough into the crook of your arm or into a handkerchief.
- We recommend that you continue to use the elevator cabs only alone or with other people traveling with you.
- Wearing an FFP2 mask in the general areas of the house is compulsory in the general areas of the hotel!

General protective measures in the Schneeberghof:

- A plexiglass protective wall was installed at the reception.
- We continue to provide hand sanitizer in many locations throughout the hotel.
- All sanitary facilities are cleaned and disinfected daily and cleaned and checked several times.
- All areas, especially the hotel rooms, are cleaned with special cleaning agents. Particular attention is paid to cleaning surfaces in the bathroom, toilet, bedside tables as well as the remote control of the TV set and the light switches. The laundry is also professionally cleaned according to the latest standards. Cleaning plans that we have drawn up with our cleaning partner apply to the entire house.
- Bedspreads and decorative pillows have been removed from the rooms.
- We kindly ask you to actively use the signs "Do not disturb" or "Please clean up" at the room doors. This allows our chambermaids to enter and clean your room without disturbing you.
- Our hotel employees regularly provide their evidence in accordance with the currently applicable legal requirements of the federal government. In addition, all vaccinated employees are obliged to submit a PCR test once a week.

Restaurant:

- All food and drinks may only be consumed while sitting at the table.
- A hand disinfection station is always right next to each buffet.
- Hand disinfection is still mandatory before self-service at the buffet.
- There is a one-way rule at the buffet in the restaurant, which is clearly indicated.
- All measures apply to breakfast, evening and afternoon buffets!
- We use the digital guest registration of "4yourguests" for a la carte guests. Anyone who cannot use this type of registration is asked to fill out a prepared form that will be destroyed 28 days after the visit.
- Due to legal regulations, the restaurant and the bar must close at 22.00 h. We ask you to leave the gastronomic areas. You are welcome to take your drinks with you in the hotel lobby or in your room.

- On your own responsibility, we ask you to continue to maintain appropriate distances from people outside the household.
- You can use the fitness room as usual. Before and after, the user is asked to thoroughly disinfect the fitness equipment as before.
- In the wellness and spa area, there are also disinfection stations that can be used for hand disinfection, but also disinfection wipes for self-disinfection of loungers or devices.
- You can use our massage and cosmetic offers as usual, while observing all hygiene and protective measures.
